## March 18, 2024

The Board of Health (BOH) held a meeting at the Town of East Bridgewater Town Offices, 175 Central Street, East Bridgewater, MA in Conference Room First Floor. BOH Members present Robert Lyons (RL) Chair, Tom Duquette Jr. (TD) Vice Chair and Andrew Hudson (AH) Clerk. Also in attendance, Jeanmarie Joyce, (JJ), Health Agent and Sandra Abban (SA) Administrative Assistant to the Board of Health.

RL called the meeting to order at 5:00 pm and stated there are no appointments and no hearings.

# **Approval of Bills**

AH made a motion to approve Amazon - Invoice #16GCHGQ6-4CT3 – Amount \$31.78 - Blood Pressure Cuff - Crystal Rock – Invoice #10222761016063 – Amount \$5.29 – Water - Happy Frog Ink – Invoice #20539 – Amount \$169.00 – BOH reflex blue ink envelopes. # **Approval of Minutes**

RL made a motion to approve March 4, 2024, minutes as submitted. TD abstained. AH seconded the motion. So, moved.

#### **Disposal System Construction Permits**

RL made a motion to approve as submitted Local Upgrade – 35 Fieldcrest Drive, East Bridgewater – (1) 310 CMR 15.405 (1), (i) A variance to allow for sieve analysis instead of perc test due to saturated soil and high groundwater. (2) 310 CMR 15.405 (1) (h) A variance to allow for 3' separation to high groundwater from required 5' by utilizing Geomat leaching system. The Geomat leaching system is being used here to eliminate the need for a mound which would interfere with groundwater runoff towards the back of the lot. AH seconded the motion. Motion approved unanimously.

#### **New Construction**

RL made a motion to approve 15 Chestnut St, East Bridgewater, MA as submitted. TD seconded the motion. Motion passed unanimously.
